



# Concert Ticket Giveaway Rules 2024

## OFFICIAL SWEEPSTAKES RULES

May 1, 2024

Any individual who enters, attempts to enter or in any way participates or attempts to participate in any sweepstakes or giveaway (“Contest”) conducted by Slawsby Insurance Agency, Inc. (hereinafter referred to as the “Sponsor”) (each such individual in hereinafter referred to as an “Entrant”) agrees to be bound by the terms and conditions provided in these Official General Contest Rules (“General Rules”), as well as by Sponsor’s interpretations of these General Rules which are final and binding in all matters relating to any Contest.

### **NO PURCHASE NECESSARY:**

Unless otherwise noted, no purchase is necessary to enter or win a prize. A purchase will also not improve your chances of winning.

### **1. ELIGIBILITY:**

Geographical, Age and Parental Consent Requirements:

Unless otherwise specified, the Contest is open to only to individuals who (i) are legal U.S. residents, (ii) who are 21 years of age or older at the time of entry and (iii) who reside within the Sponsor’s service area.

Employees, contractors, officers and directors of Sponsor, its affiliates, parent companies, subsidiaries, divisions, suppliers, distributors and advertising, promotional and judging agencies, and any third party prize provider(s) and/or prize fulfillment service (collectively, the “Contest Entities”); and members of the immediate families (spouse and biological, adoptive or step-parents, grandparents, children, grandchildren and siblings, and each of their respective spouses regardless of where they reside) or households (whether related or not) of any of the above individuals are not eligible to participate in the Contest or win the prize.

Eligibility Frequency Limits:

The Contest entry period starts on Monday, May 6, 2024, and ends on Friday, August 16, 2024 at 5PM EST. The first drawing will be Thursday, May 30, 2024, and the last drawing will be Thursday, August 22, 2024.

The entry must fulfill all Contest requirements, as specified, in order to be eligible to win a prize. Entries that are incomplete or do not adhere to the rules or specifications may be disqualified at the sole discretion of the Sponsor. You must provide the

information requested. Both the Potential New Client and the Referring Original Client will be entered to win.

You may enter only once per new potential client referred. You may not enter more times than indicated by using multiple email addresses, identities, or devices in an attempt to circumvent the rules. If You use fraudulent methods or otherwise attempt to circumvent the rules, your submission may be removed from eligibility at the sole discretion of the Sponsor.

No cash or other prize substitution shall be permitted. The prize is nontransferable. The Sponsor is not responsible if any shows are canceled or rescheduled.

No substitution of prize or transfer/assignment of prize to others or request for the cash equivalent by Winner is permitted. Winner(s) will also be notified via email within twenty-four (24) hours following selection of Winner. Prizes will be forfeited to the next runner-up if the original winner does not finalize prize recipient plans with the Sponsor within twenty-four (24) hours of the winning notification email being sent. The Sponsor shall have no liability for Winner’s failure to receive notices due to spam, junk e-mail or other security settings or for Winner’s provision of incorrect or otherwise non-functioning contact information.
